¹ Commission shall be charged for the payment sum exceeding USD 30,000 per week.

² The Bank doesn't accept USD issued till 1993 and the banknotes of 100 USD, issued in the year 2006.

³ To receive cash surpassing EUR 5,000, the payment has to be ordered to the Bank one working day before. To get the cash on the next working day till 12:00, the application needs to be presented till 14:00 of the current day.

⁴ A commission shall not be charged to individuals paying the main deposit sum, if the deposit was made in cash.

⁵ Cash payment is realized if the Customer has presented previous application to the Bank: USD – in one Bank's working day; other currency – in two Bank's working days. To get the cash on the next working day till 12:00, the application needs to be presented till 14:00 of the current day. Cash payment can be ordered only under the condition that at the time of the application for the current account of the Customer is ordered by the amount or its equivalent in another currency.
